Play Area Compound Matting.

There is an issue at the Northwest corner of matting by the new personnel gate that possibly constitutes a trip hazard due to the surrounding grass area being depressed and exposing the mat edging. The surrounding substrate/soil/grass level needs building up level with the matting to affect a remedy.

Secondly the matting surface adjacent the grass is becoming embedded with grass strimmings and albeit at an early stage this will encourage moss growth creating a slip hazard and premature break down of the surface. A 60v backpack blower for use by our contactor is recommended so the mat edges may be blown clean and freed of all grass cuttings after strimming. Cost is around £200 for the blower plus £170 for a 4Ah battery.

Play Area Railing fixture to new gate.

There is an issue again at the Northwest gate that constitutes a nip point hazard due to the absence of a mechanical fixing between the hinge post of the gate and the adjacent railing. The contractor should be required to return and remedy asap.

Car Park Weed Control & Hedging.

The surface of the car park is generally in good order but there is, not unexpectedly, weed growth to the central area and sides which requires attention by spraying asap. The areas are not great, possibly amounting to only a third of the entire surface and would only require a certified operator with backpack spray equipment such as Pearsons could provide. A second application may be required at a later stage to ensure there is no recurrence in late summer.

It is understood that the hedges adjacent to the main gate are due to be cut on the 9th June and thereafter a schedule exists for the all the remaining car park and recreation ground hedges.

Recreation Field. Grass condition.

The grass height was seen to be completely unacceptable for a community playing area and appears not to have been moved for some considerable time. Upon contacting the contractor, it was made clear that it had not been cut as per schedule as they had lost their key to the recreation ground. I have a replacement key ready for their collection tomorrow when they will attempt to cut the grass and have an assurance, they will then cut it again twice thereafter at weekly intervals to try to obviate the thatching that's likely to occur due to its excessive length.

Rear Gate to Car Park & adjacent Fence.

Firstly, the gate and posts require a penetrating preservative oil.

In order to make the gate self-closing and latch without using force, it is probable that the gate will need to be re-hung by repositioning the hinges. The latch fixings are loose and also requires attention. The cross rails of the low fence to the side of the gate are in a bad state with the top one in particular splintered and could be considered a hazard. Its possible the supporting fence posts are also nearing the end of their life, and these should be assessed by the contractor before fitting new cross rails.

Tree 'Compound'.

Neither new trustee was familiar with the background to the actual purpose or agreed maintenance of this enclosed and locked area, but it was not difficult to see that this area is grossly overgrown with pernicious weeds and grasses that are and will continue to badly affect the various tree saplings that have been planted. Was the school envisaged as a participant in its upkeep?

Recreation Ground Metal Gates.

These are not in particularly satisfactory order. It is clear that the building work to the school wall has disturbed the proper closing of these gates, as the small personnel gate abuts the main gate before being fully closed making it impossible to temporarily fasten (or padlock) via the sliding bolt mechanism. Again, re-hanging is the only effective option if they are to operate as intended.
